### **Land Transport Act**

The Land Transport Act 1998 has been amended by the Local Government Act 2002 Amendment Act 2019 (2019 No 54), effective 22 October 2019, the Legislation (Repeals and Amendments) Act 2019 (2019 No 59), effective 29 October 2019 and the Land Transport (Wheel Clamping) Amendment Act 2019 (2019 No 70), effective 2 January 2020.
