Chapter 1 — Environmental Law — Sources, legislation and governance

• Chapter 1 has been reviewed and updated by Dr Kenneth Palmer. In particular, content has been updated to reflect recent Supreme Court and Court of Appeal judgments; residential density standards introduced in the Resource Management (Enabling Housing Supply and Other Matters) Amendment Act 2021; and the Pae Ora (Healthy Futures) Bill 2021.

Chapter 2 — Resource Management Act 1991 — Purpose and national direction

• Chapter 2 has been reviewed and updated by Dr Kenneth Palmer to include updated content on medium density residential standards; and recent Court of Appeal and High Court judgments in particular *Port Otago Ltd v Environmental Defence Society Inc* [2021] NZCA 638.

Chapter 3 — Resource Management Act 1991 — Regional and District policy and plans

 Chapter 3 has been reviewed and updated by Dr Kenneth Palmer to include reference to requirements for regional policy statements to address matters of climate change; and changes to urban residential zoning under the NPS-UD.

Chapter 5 — Coastal Environment

• Chapter 5 has been reviewed and updated by Derek Nolan QC to include reference to *Minister of Conservation v Mangawhai Harbour Restoration Society Inc* [2021] NZHC 3113 which could have significant impacts on the management of wetlands in the CMA; and *Port Otago Ltd v Environmental Defence Society Inc* [2021] NZCA 638 establishing the hierarchy of policies in the NZCPS.

Chapter 7 — Minerals and petroleum

 Chapter 7 has been reviewed and updated by Daniel Minhinnick and James Winchester with reference to the Supreme Court decision *Trans-Tasman* Resources Ltd v The Taranaki-Whanganui Conservation Board [2021] NZSC 127.

Chapter 8 — Water

• Chapter 8 has been reviewed and updated by Bal Matheson and Daniel Minhinnick with reference *Re Otago Regional Council* [2021] NZEnvC 164 which considered the transitional approach to giving effect to the NPS-FM 2020.

Chapter 13 — Noise

 Chapter 13 has been reviewed and updated by Derek Nolan QC with reference to Nottingham Forest Trustee Ltd v Unison Networks [2021] NZCA 227 in the context of the test to be used in nuisance cases.

Chapter 15 — Heritage

• Chapter 15 has been reviewed and updated by Dr Kenneth Palmer, in particular to include reference to *Redmond Retail Ltd v Ashburton District Council* [2021] NZHC 2887 in relation to resource consents to demolish or remove listed buildings; *Re Reeder (on behalf of Ngā Pōtiki)* [2021] NZHC 2726 and *Re Ngāti Pāhauwera* [2021] NZHC 3599 in relation to customary title, customary rights and recognition of wāhi tapu; and the impact of heritage orders on the medium residential density standards.
