The Laws of New Zealand

- the "Building and Construction" title as a result of the Building (Building Products and Methods, Modular Components, and Other Matters) Amendment Act 2021 of which ss 6(7), 9, 16(3), 21, 23(1), 24 to 29, 33 to 45, 50, 54, 60, 72 to 77, 83, 85 to 91, and 95 came into force on 8 June 2021:
- the "Consumer Credit" and "Personal Property Securities" titles as a result of the Credit Contracts Legislation Amendment Act 2019 of which: ss 33, 36, 40(3), 45, 50 (except new ss 131B and 131C), 64, and 68 came into force on 1 June 2021; ss 5(2), 50 (new ss 131B and 131C only), 59 to 63, and 65 to 67, and Schedule 2 came into force on 1 October 2021; and the remainder of the Act came into force on 1 December 2021;
- the "Local Government" title as a result of the Water Services Act 2021 which (except for ss 58, 138, 139, 141(c) and (d), 144, 146(1)(c), 147, and 148) came into force on 15 November 2021 and the Health (Fluoridation of Drinking Water) Amendment Act 2021 which came into force on 13 December 2021;
- the "Māori Affairs" and "Treaty of Waitangi" titles as a result of the Moriori Claims Settlement Act 2021 which came into force on 26 November 2021 and the Ahuriri Hapū Claims Settlement Act 2021 which came into force on 14 December 2021;
- the "Maritime Law: Shipping and Navigation" title as a result of the Maritime Transport (MARPOL Annex VI) Amendment Act 2021 which came into force on the 16 November 2021;
- the "Mental Health" title as a result of the Mental Health (Compulsory Assessment and Treatment) Amendment Act 2021, which (except ss 4, 6, 7, 8, 10, and 12) came into force on 30 October 2021;
- the majority of the titles in the Laws of New Zealand due to amendments made by the following legislation:
 - the Legislation Act 2019 (other than Part 4, s 148, and the provisions that were already in force) which came into force on 28 October 2021;
 - the Secondary Legislation Act 2021, of which s 3 and Schedules 1 to 32 (except the items in those Schedules that are listed in the Schedule to the Secondary Legislation Act Commencement Order 2021) came into force on 28 October 2021;

- the Legislation (Repeals and Amendments) Act 2019, of which Part 2 (ss 6 16) was bought into force on 28 October 2021; and
- the Legislation Act (Amendments to Legislation) Regulations 2021 and the Legislation Act (Sub-delegated Secondary Legislation) Regulations 2021 which came into force on 28 October 2021.
