## The Laws of New Zealand

The first reissue of the "Sale of Goods" title, written by Matthew Barber, is now available online. The title provides authoritative guidance on the law governing contracts of sale. It includes a historical overview of previous sources of law leading to their subsequent codification and examines the current regime applying to contracts of sales consolidated into the salient provisions of the Contract and Commercial Law Act 2017 in New Zealand. The reissued title offers coverage of important topics such as the formation of the contract and its proprietary effects, as well as the passing of risk, transfer of title to goods by non-owners, the duties of the parties, and the remedies available to the seller and buyer. It also examines the regime applying to export and international sales, with up to date coverage of costs insurance and freight (cif) and free on board (fob) contracts and other common international contracts, bills of lading, letters of credit and performance bonds, imports, and restrictions on imports. The title also provides essential guidance on the regime applying under the United Nations Conventions on Contracts for the International Sale of Goods, and on its relationship with other law.

- the "Fisheries" title as a result of the Māori Commercial Aquaculture Claims Settlement Amendment Act 2022, which came into force on 12 April 2022;
- the "Health" title, as a result of the End of Life Choice Act 2019, which came into force on 6 November 2021;
- the "Minerals and Mining" title, as a result of the Crown Minerals (Decommissioning and Other Matters) Amendment Act 2021, which came into force on 2 December 2021; and
- the "Religion and Religious Institutions" title, as a result of the End of Life Choice Act 2019, which came into force on 6 November 2021, and the Conversion Practices Prohibition Legislation Act 2022, most of which came into force on 18 February 2022.
