The Land Transport (Approved Vehicle Surveillance Equipment) Notice 1994 was amended by the Land Transport (Approved Vehicle Surveillance Equipment) Notice 2023, effective 1 November 2023.

The Land Transport (Approved Vehicle Surveillance Equipment) Notice 2008 was amended by the Land Transport (Approved Vehicle Surveillance Equipment) Notice 2023, effective 1 November 2023.

The Land Transport (Motor Vehicle Registration and Licensing) Regulations 2011 was amended by the Land Transport (Motor Vehicle Registration and Licensing) Amendment Regulations 2023, effective 1 October 2023.

The Land Transport (Regulatory Fees) Regulations 2023 came into force on 1 October 2023, revoking and replacing the Land Transport (Certification and Other Fees) Regulations 2014, Land Transport (Driver Licensing and Driver Testing Fees) Regulations 1999, and Transport Services Licensing Regulations 1989.

The Land Transport (Road User) Rule 2004 was amended by the Land Transport (Road User) Amendment Rule 2023, effective 1 October 2023.

The Transport Services Licensing Regulations 1989 was amended by the Land Transport (Regulatory Fees) Regulations 2023, effective 1 October 2023.
