The Australian Lawyers Cricket Council is sending a squad of 33 Australian legal practitioners to the 4th International Lawyers' Cricket World Cup, to be held at New Delhi, India between 12 – 22 October 2013. Previous tournaments have been held at Hyderabad, India (2007), England (2009), & Barbados (2011). Australia won the World Cup at The Oval on 4 August 2009.

The Australian Lawyers Cricket Council grew out of the desire, by a group of like-minded Australian legal practitioners, to promote the rule of law throughout the Commonwealth, by using cricket as an opportunity to meet regularly at different locations and to interact with our legal practitioner friends from elsewhere. The motto of the International Lawyers Cricket World Cup tournament is '*Cricket for Friendship*'.

The response from Australian legal practitioners has been steadily growing and this is the first tournament, to which Australia is sending two teams.

Australia's squad is made up of practitioners, who are natives of New South Wales, Queensland, Australian Capital Territory, South Australia & Western Australia. Selection is entirely merit based. The 1st XI is almost exclusively comprised of current and former State

representatives (Sheffield Shield & 2nd XI), one former Australian A player and current or former first grade players. The 2nd XI team has a less competitive, more social aspect to it.

The greatest concentrations of interest and support for the 2013 touring squad is by barristers and solicitors from New South Wales, barristers and solicitors from Queensland, and Australian expatriate legal practitioners in England.

Australia plans to host the next tournament in January 2016, to which event you are warmly invited to attend.

International rules

The International Lawyers Cricket World Cup committee has promulgated age based rules. No XI may field more than 5 players in any match, who are 32 years of age or younger, so that the competition is not swamped with exceedingly talented, young, legal practitioners.

Furthermore, at the other end of the spectrum, anyone, who has played first class cricket, must be 42 years of age or older, for much the same reason.

Jock is a right arm (once quick, now not so) bowler and right handed batsman. He played over 100 1st grade games with the Sydney University and North Sydney Clubs. He captured over 400 grade wickets in his career. Jock has toured the UK in 1993, 2009 and 2010, and Barbados in 2006, and now plays with the I Zingari and Primary clubs. This is Jock's 49th consecutive season of cricket. He is currently the Vice President of both the North Sydney and Sydney University Cricket Clubs.

Jock practices as a barrister in Sydney, specialising in commercial litigation, corporations law and insolvency.

Andrew Bell SC

21 February 1966



Andrew is a right hand opening batsman, occasional spin bowler and back up wicketkeeper. Andrew played for Sydney University Cricket Club, Magdalen College Oxford and, in more recent years, has been a prominent member of the Wentworth Wombats, who have had three very enjoyable tours to England.

Dr Bell is a Sydney silk specialising in transnational litigation, international commercial arbitration and private international law. He is the author of a number of books on these topics and is also an Adjunct Professor of Law at the University of Sydney Law School.

Andrew is a right handed batsman and right arm medium pace bowler. He is making his legal cricket debut in New Delhi.

1 December 1976

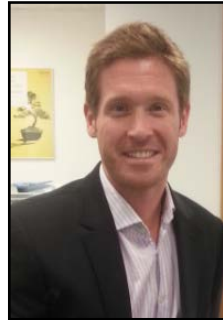


Chris is a right handed middle order batsman and right arm medium pace bowler. Chris was a member of the Australian team at the 1st LCWC in India.

He now plays in the Middlesex League.

Paul is a right handed batsman and right arm slow bowler. He is a regular member of the Edmund Barton Chambers team that contests the Lady Bradman and Edward St John trophies each year.

Paul practises as a barrister in Sydney. He is member of Edmund Barton Chambers. Although Paul has a general commercial practise, he specialises in bankruptcy, insolvency and migration law.

Troy is a right handed top order batsman, a right arm medium pace bowler and occasional wicketkeeper. New Delhi 2013 will be Troy's 3rd LCWC following appearances at the inaugural event in India in 2007 and England in 2009.

Troy is an Associate at Sydney-based firm Wilshire Webb Staunton Beattie Lawyers. Troy specialises in planning and local government practice, primarily representing local councils.

Jonathan Garforth

Jonathan is a right handed top order batsman and right arm swing bowler. Jonathan plays his club cricket in London for Richmond Cricket Club, which competes in the 1st division of the Middlesex County Cricket League. He represented Australia at previous LCWC's in England in 2009 and the West Indies in 2011.

Jonathan commenced his legal career with Australian law firm Clayton Utz before moving to London with Freshfields Bruckhaus Deringer LLP as an associate in its global financial institutions group. Jonathan advises banks, financial institutions and private equity firms on all aspects of financial services regulation, with a focus on retail banking. Jonathan is currently a senior legal counsel in HSBC Bank's UK Retail Banking and Wealth Management business.

Lachlan Gyles SC

Lachlan is a left handed batsman and a leg spin bowler. Lachlan has played for Gordon DCC and for Australia House (UK), and Rangers Cricket Club and the NSW Bar team. He has been a member of a numerous tours including: AOC tour of the UK in 1996; the Australian Bar Hong Kong tour 2006; and the Wentworth Wombats UK tour 2009.

Lachlan worked as a solicitor in New York, London and Sydney, before going to the Bar in 1991. Lachlan took silk in 2008, working primarily in commercial / equity and insurance cases, as well as having an interest in sports law.

Ron Heinrich AM

6 June 1948



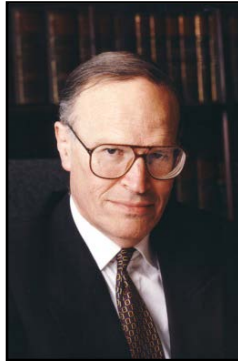
Ron is a left handed lower order batsman and a wily right arm slow bowler. He is the senior member of the team and was one of the driving forces behind establishing the first LCWC in India, as the then President of the Commonwealth Lawyers' Association (CLA). Ron is the only Australian to play in all 3 LCWC's to date.

Ron is a Senior Consultant, and former Senior Partner, at TressCox Lawyers in Sydney. Ron is a former President of the Law Society of New South Wales, Law Council of Australia and the CLA. Ron specialises in the areas of mergers and acquisitions, corporations law, trade practices law, administrative law and estate and succession planning.

Ron was made a Member of the Order of Australia (AM) on Australia Day 2013 for 'significant service to the law, and the legal profession'.

**The Hon Dyson
Heydon AC QC**

1 March 1943



The Hon Dyson Heydon AC QC is the patron of the ALCC. He played cricket for 20 years, finishing as a right arm swing bowler. His career highlight was playing for the Prime Minister's XI against the touring South Africans in 1964, when he captured 2 for 14, taking the prized wickets of van de Merwe and Lindsay.

The Hon Dyson Heydon AC QC was educated at The University of Sydney (BA) and Oxford University (MA, BCL), was Rhodes Scholar for New South Wales in 1964 and Vinerian Scholar for 1967. He was a fellow of Keble College Oxford in 1967 - 1973, a Professor of Law at the University of Sydney from 1973, and Dean of the Faculty of Law in 1978 - 1979. He practised at the Bar as a junior from 1979 and as Queen's Counsel from 1987 until 2000, when he was appointed to the New South Wales Court of Appeal. He was a Justice of the High Court of Australia from February 2003 to March 2013. He has written various textbooks and monographs on evidence, equity, trade practices law, restraint of trade and economic torts.

Thos Hodgson

17 February 1953



Thos is a right handed batsman and cricket tragic. He played for the Sydney University Cricket Club and over the many decades, which his career has spanned, he has played cricket all over the world, including tours with the Australian Bar Association, the Australian Cricket Society, the Australian Old Collegians, the Bradman Foundation XI, and the Wentworth Wombats. He has captained the Edmund Barton Chambers XI since 1987.

Thos was called to the NSW Bar in 1979 and is a barrister, specialising in family law matters. Prior to this he worked for a London firm of solicitors, ostensibly to hone his litigation skills but in reality to adapt his cricketing skills to English conditions. He also occasionally dabbles in criminal and liquor licensing law.

Andrew James

2 February 1983



Andrew is a fast bowler and middle order batsman. Andrew has previously played for the Australian Capital Territory, Australia U19's, Western Australia 2nd XI and the Prime Minister's XI. In 2001 Andrew spent 6 months at the Australian Institute of Sport in Adelaide and was contracted to Western Australia for 6 seasons.

Andrew is an Associate at CMS Cameron McKenna LLP in London. Andrew specialises in Mergers and Acquisitions predominantly in the Oil and Gas industry. Andrew commenced his career at Clayton Utz in Perth after completing his law degree at the University of Western Australia.

Mark Johnston

4 November 1975



Mark is a left handed opening batsman. He has played 1st grade in the Illawarra competition since the age of 15, save for 2 seasons with Campbelltown in the Sydney 1st grade competition. A former Country Colts representative and Illawarra captain, Mark is a life member of his club, Keira, and is the current President of the Illawarra Cricket Association.

Mark worked as a solicitor in Wollongong with a number of firms before opening his own firm, Johnston Legal, in 2013. He is an accredited specialist in personal injury law and a casual tutor at the University of Wollongong's law faculty.

Jason Keane

26 March 1974



Jason is a right arm seam and swing bowler and hard hitting batsman. He currently plays for the North Sydney District Cricket club, where he has taken over 300 grade wickets, and was Club Champion player in 2003 / 2004.

Jason is a Sydney based solicitor practicing in criminal law and commercial litigation at the firm Macedone Legal. Having recently completed the assessment program, he hopes to be confirmed as an Accredited Specialist in criminal law in October.

Warwick Lindsay

27 July 1983



Warwick is a wicketkeeper and right handed middle order batsman. Warwick has played grade cricket for the University Club in Brisbane and now plays for the Richmond Club in London. Warwick represented Australia at the 3rd LCWC in the West Indies in 2011.

Warwick is an Associate with Berwin Leighton Paisner in London and specialises in infrastructure and energy projects.

Michael Maher

9 May 1970



Michael is a top order batsman and right arm off spin bowler. Michael has played most of his cricket in western country New South Wales. In the last 15 years Michael has toured England, Austria, Chile, Argentina, Slovenia and Malaysia with the Galah Cricket Club. Michael spent a season playing cricket in Dublin as an overseas player and has toured with the New South Wales Police cricket team.

Michael is a solicitor with the NSW Office of the Director of Public Prosecutions, practising criminal law and is based in Dubbo. Prior to his current position, Michael spent 15 years working for New South Wales Police in Legal Services.

Daniel Maroske

28 March 1983



Daniel is a right handed batsman and a left arm seam bowler. His cricketing highlights include bowling to all 10 test playing nations and hitting the winning runs in the 2nd LCWC final at The Oval in 2009. Daniel represented Australia at previous LCWC's in the England in 2009 and the West Indies in 2011. Daniel hit the winning runs to win the World Cup at The Oval in 2011.

Daniel is a solicitor of the Supreme Court of Queensland and is currently an Associate with the Financial Conduct Authority in London, specialising in regulatory litigation and enforcement actions involving wholesale investment firms and individuals.

Alex Martin

16 May 1961



Alex is the President of the ALCC. Alex is a wicket-keeper and opening batsman. Alex represented Australia at previous LCWC's in India 2007 and the England in 2009. Alex is the captain of the 2nd XI in 2013.

Alex is the principal of Martin Legal in Sydney, mainly doing commercial litigation and appellate work. Martin Legal also owns *go go conveyancing*, one of Australia's sponsors. *go go conveyancing*, specialises in real estate transactions in New South Wales.

Andrew Morrison RFD SC

20 May 1950



Andrew is a right handed batsman and off spin bowler. He has been a member of the Wardellians cricket team since the early 1980's, playing barristers' social cricket and is its current captain.

Dr Morrison RFD SC has practised as a barrister in NSW since 1976 and was appointed Senior Counsel in 1993. He has since been appointed as Queen's Counsel in Tasmania and Western Australia.

Rajeev Pillay

4 December 1988



Rajeev is a right handed top order batsman. Rajeev played representative cricket, including junior NSW cricket, until the age of 17 before commencing his tertiary education. Rajeev has played with many members of the current Australian test side.

Rajeev is a solicitor in the Sydney office of Gadens Lawyers, a full service commercial firm. Rajeev practises in financial services debt recovery, insolvency and commercial litigation.

Karl Prince

30 October 1980

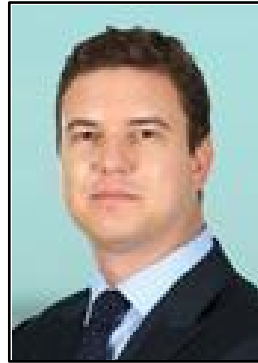


Karl is a left handed middle order batsman and left arm off spin bowler. Karl was a member of the Australian team at the 1st LCWC in India in 2009 and captained the Australian team which won the 2nd LCWC in England in 2009. Karl is returning as the captain of the 1st XI in New Delhi in 2013.

Seb represented Australia at previous LCWC's in England in 2009 and the West Indies in 2011. Seb won the 'batsman of the tournament' award in at the 2nd LCWC, after scoring two centuries.

Seb is a solicitor, working for Hartcher Reid, a general practice firm on the New South Wales Central Coast.

Stewart Roberts

Stewart is a right handed batsman and occasional right arm off-spin bowler.

Stewart is a Partner in Makinson d'Apice, a Sydney CBD firm. He specialises in litigation.

Greg Rowell

Greg is a right hand lower order batsman and a right arm fast bowler. Greg grew up in Canberra and pursued the 'baggy green dream' for most of his adult life. Greg did not quite get there, but he did play for New South Wales, Queensland, Tasmania and Australia A. He played 1st grade between 1993 and 2005 for the Western Suburbs Cricket Club in the Brisbane grade competition. Greg represented Australia at the 2nd LCWC in England.

Greg is a Special Counsel in the Brisbane office of Mills Oakley Lawyers. He works in the Corporate and Commercial team and has particular expertise in business succession planning, private advisory work and all areas of estate planning and probate.

Andrew Ryan

Andrew is a right handed top order batsman and a right arm medium-fast bowler. Andrew has played in both the Middlesex and Hertfordshire leagues since moving to the UK 7 years ago. In recent years, he has focussed his energies towards coaching youngsters in Kenya with the charity, Cricket Without Boundaries.

3 July 1988

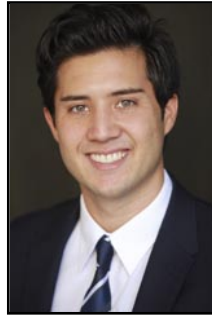
